For immediate release:

The St. Clair County Sheriff's Office Narcotics Division conducted a felony drug warrant round up on April 8<sup>th</sup>, 10<sup>th</sup>, and 11<sup>th</sup>. The Sheriff's Office Narcotics Investigators were assisted by Pell City and Moody Police Department's Narcotics Units, Ashville PD, Ragland PD, Argo PD, Margaret PD, Odenville PD, and Springville PD.

Sheriff's Office Narcotics Investigators and assisting law enforcement traveled countywide during the drug warrant round up attempting to locate and arrest wanted felons. 28 people were arrested for felony and misdemeanor drug crimes that included possession of methamphetamine and the unlawful possession of prescription medication. Subjects were also arrested that were wanted for crimes that included felony thefts and a sex offender violation. New cases were made on a convicted felon who possessed a firearm, and another individual for possessing methamphetamine in the presence of children.
